Terms & Conditions of Hire.

A \$100.00 deposit is required to secure your hall hire.

Hire fees are to be paid no less than 7 days from the date of the hire.

Cancellations 30 + days from the date of hire will be entitled to a full refund. Cancellations less than 30 days from the date of the hire will forfeit their \$100 deposit.

All Hirers are required to supply Wellwood Health with a credit card as a form of a bond. The Credit card will be kept on file and only charged if damages occur.

The hirer is to notify Wellwood Health 5 days prior to the hire taking place exactly what inclusions they will be requiring. Failure to do so may result in inclusions not being available.

Wellwood Health is not liable to the Hirer for any loss suffered by the Hirer arising out of the Hirer's use of Wellwood Health. The Hirer releases Wellwood Health from any claim made against Wellwood Health arising out of, in connection with or caused by the Hirer's use.

The Hirer indemnifies Wellwood Health from and against all claims, demands, actions, costs and expenses arising out of, in connection with or caused by the Hirer's use of Wellwood Health.

The Hirer agrees to effect public liability insurance for an amount of no less than \$10 million per occurrence and to provide a Certificate of Currency to Wellwood Health prior to commencement of the hire period. The Hirer agrees to keep the policy in force for the duration of the hire period.

The Hirer agrees to reimburse Wellwood Health for the full cost of repairing any damage caused by the hirer throughout the hire period.

The Hirer agrees to notify Wellwood Health of all injuries or damage arising out of the Hirer's use of Wellwood Health within 7 days of becoming aware of the injury or damage.

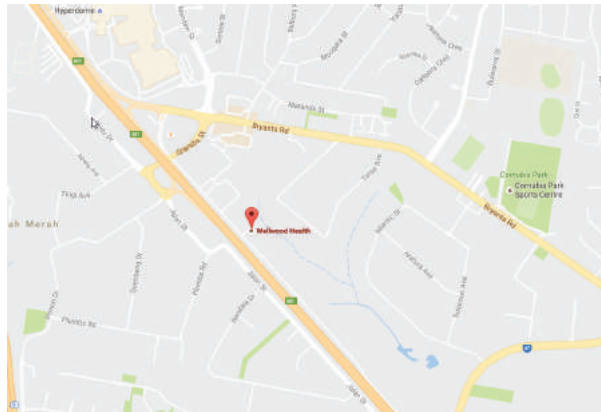
The Hirer and their guests are permitted to park in the following areas:
On the grassed car park to the back of suites or on the street to the front of the cabin.

All cars and its contents are to be left on site at the owners own risk.

The Hirer is to leave Wellwood Health and it was found at the end of each hire. Failure to leave the above areas in a satisfactory condition will result in a \$50 per hour cleaning charge. This charge will be made against the hirers credit card stored on file.

Marketing Terms and Conditions

1. Wellwood Health will not commence any work until marketing fee's have been paid in full and in advance.
2. Marketing fees are non refundable.
3. All marketing material must be supplied to Wellwood Health at least 30 days from the date of the hire.
4. Wellwood Health will place the hirers event / workshop information on the following platforms:

 - Graphics (at least two images no lower than 2.5mb)
 - Contact details of hirer (name, phone, email and website)
